LIMITATIONS APPLY including limited *married filing separately* (MFS) returns
no rental or farm income (Sch E or F)
no loss on business income (Sch C)

WHAT TO BRING:

- **Social Security Cards** (or ITIN cards or ITIN letters) for all members of the household
- **Picture Identification** for taxpayer (and spouse, where applicable)
- **Proof of all income** including W-2 and 1099 forms, and self-employment records
- **Child Care Information**, including record of payment with name, address, and tax ID# of childcare provider
- **Direct Deposit Information**, including bank routing and account numbers (such as a voided check)
- **Health Insurance Information**, Form 1095-A, 1095-B and/or 1095-C if available
- **Prior year tax return**, if available (federal and state)
